HRSA Funding Awards Combat Mental Health and Opioid Abuse



In September, the Health Resources and Services Administration (HRSA) announced nearly \$200 million in funding nationwide to increase access to substance abuse and mental health services. The funding will support services to focus on the treatment, prevention, and awareness of opioid

abuse in the primary care setting by increasing personnel, leveraging health information technology, and providing training. 1,178 health centers have been selected for funding, including 20 centers in New Jersey.

"No corner of our country, from rural areas to urban centers, has escaped the scourge of the opioid crisis," said **United States Department of Health and Human Services (HHS) Secretary Tom Price, MD**. "The Trump Administration is taking strong, decisive action to respond to the crisis caused by the opioid epidemic. These grants from HRSA go directly to local organizations, which are best situated to address substance abuse and mental health issues in their own communities."

Brain Builder



In December 2017, George Washington University and RCHN Community Health Center released a policy issue brief entitled "State Economic and Employment Losses if Community Health Center Funding is not Restored."

Key Findings from the policy brief include:

1. In New Jersey, the loss to GDP in 2018 is estimated to be between \$212 million - \$453 million. The estimated loss of jobs is between 1,970 – 4,224.
2. Nationally, the number of jobs lost in 2018 would range from 76,000 – 161, 000. States' gross domestic product (GDP) could be reduced by \$7.4 - \$15.6 billion.

VNACJ CHC Tackles Breast Cancer with Crucial Catch Event



The Visiting Nurses Association of Central Jersey (VNACJ) Community Health Center (CHC) hosted a community wide breast cancer awareness event on October 26th. The "NFL Crucial Catch: Intercept Cancer" event took place in Asbury Park and was co-sponsored by the American Cancer Society.

VNACJ CHC's Chief Clinical and Quality Officer, Dr. Gail Reilly and Physician Dr. Michael Marro, wrote mammogram scripts for 20 patients.

The doctors also filled up their capacity at Jersey Shore Imaging by signing up 14 patients for mammogram screenings. The NFL Crucial Catch initiative focused on raising money for funding to support increased access to cancer education, prevention, and screening resources in underserved communities.

- How to provide **opioid substance abuse treatment** integrated within primary care.

Breakout sessions will allow participants to learn from their colleagues and share innovative projects reinforcing our FQHC Peer Learning Network.
