A Message from the President & CEO

As we close out the year, we can proudly say that we remain as committed as ever to support our Federally Qualified Health Centers (FQHCs) in their efforts to sustain and expand access to affordable, equitable, and high-quality healthcare for all New Jerseyans.

Serving as the State's largest primary care safety net providers, our 23 FQHCs and one FQHC Look-Alike put up some remarkable primary care numbers this past year. In 2023, they provided healthcare services for over 577,000 patients statewide, providing over 2.07 million medical, dental, and behavioral health visits. Together, they served over 318,880 Medicaid patients, 149,220 uninsured, 29,840 Medicare, and 79,115 privately insured patients. Compared to 2022, New Jersey health centers overall served 5.0% more patients in 2023.

These health center accomplishments are extraordinary, given the many challenges they have tackled and the ones they continue to face. The challenges that take center stage are the post-COVID inflationary impacts on their cost of operations, reduced funding, widespread workforce shortages and turnover, and the need to navigate a complex reimbursement mechanism that often leaves them operating at a precarious margin.

Some of these extraordinary health center accomplishments are detailed in the E-Magazine pages that follow—their efforts to deliver comprehensive whole-patient care regardless of the patient's ability to pay, adding new service sites and hours, and creating social service connections that strive to produce better health outcomes for the communities they serve.

Also detailed in the pages are NJPCA and FQHC policy and advocacy efforts, training and technical assistance highlights, and NJPCA social events that foster stakeholder engagement and collaborations.

We are proud to serve our FQHCs and look forward to an exciting year of patient care excellence in 2025!

CCHN's executive team, along with Dr. Kaitlan Baston, Commissioner of the NJDOH, and members of the local healthcare community, raised concerns regarding the healthcare of rural Cumberland County communities and proposed solutions to healthcare barriers such as transportation to and from medical appointments, affordability, and cultural proficiency.

Union City High Goes Back to School with North Hudson Community Action Corporation

Every year, Union City High School, a New Jersey award-winning educational facility, is overwhelmed with new students, some of whom are new to the area or new to the country entirely. Before school opens, every student must have a physical exam, and many of them are uninsured and have no existing relationship with a medical provider. North Hudson Community Action Corporation always steps in to help.

Last year, North Hudson's staff provided physicals to 67 students and administered 240 vaccines at a high school event. One hundred thirty-two more vaccines were given to students who booked appointments at North Hudson's flagship site in West New York on subsequent weekends.

This year, North Hudson's first inschool event held on August 24 had 80 students scheduled to be seen. Throughout September, North Hudson arranged Sunday appointments for the overflow students to meet the health needs within the school-based community.

The New Jersey Healthcare Coalitions in the North, Central, and South regions recently conducted a community-based tabletop exercise titled "Operation Iron Horse: Regional Chemical Surge Exercise." Held on February 26, 27, and 29, this event welcomed coalition members from across the state to participate within their respective regions.

Community Health Centers play a pivotal role in supporting patients during and after surge events. The primary goal of the exercise was to identify and address gaps in medical surge capacity, healthcare response coordination, and the continuity of operations among all coalition members.

The scenario involved a train derailment in each region, with a train carrying unknown hazardous materials that leaked into the environment, severely impacting local residents and businesses. The NJPCA Emergency Management Team facilitated the exercise for health center participants attending from the following centers: Alliance Community Health Center, CAMcare Health Corporation, CHEMED (Center for Health Education, Medicine, & Dentistry), Metropolitan Family Health Network, and Saint James Health, Inc.

Participants had the opportunity to discuss their strategies for responding to chemical and radiological surges, as well as decontamination procedures and



evacuation protocols. The focus was also on enhancing communication with partners, patients, and the community during emergency situations.

Advocacy in Action Advocacy in Action New Jersey FQHCs Mobilize at Capitol Hill

On February 14, New Jersey FQHC members descended on Capitol Hill for the NACHC Policies and Issues Forum, giving a voice to the issues faced by the medically underserved populations in their home state. Advocates drove home the need for continued support for increased community health center and workforce funding, 340B Discount Drug Program protections for covered entities, and the extension of telehealth flexibilities beyond December 2024.

During the Hill visit, New Jersey Health Center delegation also conducted Congressional meetings at the offices of Congresswoman Bonnie Watson Coleman, Congressman Chris Smith, Congressman Donald Norcross, Congressman Andy Kim, Congressman Josh Gottheimer, and Congressman Jeff Van Drew (not pictured). NJPCA Clinical Quality Forum Driving Health Improvements

This year's Annual Clinical Quality Forum was held on April 17 at the Hilton Garden Inn in Hamilton, New Jersey. Thanks to our sponsor, Horizon Blue Cross Blue Shield, the event was a success. Dr. Tanya Pagán Raggio-Ashley, Acting Chief Medical Officer for the Centers for Medicare and Medicaid Services (CMS), was in attendance and provided HRSA updates.

The first session, **"HIV Stigma: Addressing Bias in Medical Documentation"**, was presented by Adam Thompson, MPH, AIDS Education & Training Center Program. The session offered an overview of the effects of HIV-related stigma on patient behavior and how it impacts treatment decision-making.

Renaye James Healthcare Advisors speakers, Christina Mister and Tawonna Melton reviewed the development, implementation, and evaluation of a team-based, care management program for patients with diabetes mellitus in the session, **"Team-Based Collaboration for Diabetes Care Management."**

Jeneen Skinner, LPN and Michelle Adyniec, RN from Camden Coalition provided the participants with an in-depth look at Camden Coalition's COACH framework and how it engaged program participants and supported them in taking control of managing their blood pressure in their presentation **"Patient-Centered Approaches to Improve Blood Pressure Self-Management."**

The final session, **"The Integration of Social Determinants of Health (SDOH) - Informed Policies into Clinical Care and Management",** presented by Dr. Kevin Lombardi, Manager of Policy, Research and Health Promotion from the National Center for Health in Public Housing. He discussed key recommendations and promising practices regarding the integration of SDOH-informed policies into patient care.

Towards the end of the forum, members had the opportunity to exchange ideas with peer group members and experts, exploring strategies for improved health outcomes for all patients.

BUILDING A HEALTHY COMMUNITY, ONE PATIENT AT A TIME

Over 250 participants joined in Princeton to share best practices, learn from experts in the healthcare field, and network with colleagues from around the State at the NJPCA Annual Conference. 
